Deduct Water Meter Program Application

DEDUCT WATER METER PROGRAM INFORMATION

What is a Deduct Water Meter?

A Deduct Water Meter measures the amount of water not discharging into the Village's sanitary sewer system, such as water used for lawn irrigation systems or outside hose connections. The measurement of the Deduct Water Meter shall be deducted from the consumer's sewer usage based upon the reading of the primary water meter.

NOTE: There shall be no permanent or temporary water piping system that passes water from the deduct meter to any interior water outlet.

Where can I get a Deduct Water Meter?

Deduct Water Meters can be picked up at the Village's Wastewater Treatment Plant Office at 350 Mill Avenue after obtaining and paying for the Building Permit.

Who can install a Deduct Water Meter?

It is the responsibility of the property owner to hire and arrange installation of the Deduct Water Meter by an Illinois licensed plumber.

NOTE: Deduct Water Meters must be installed similar to regular water meters, complete with pull wire between the meter and the outside remote reader. The Deduct Water Meter pull wire may be run in the same conduit as the regular water meter, wherever feasible.

NOTE: The Deduct Water Meter must be installed after the main water meter and located in the same area and must be accessible for inspection. All hose connections must be protected by a vacuum breaker. All underground sprinkling systems must have a backflow valve.

Is a building permit required to install the Deduct Water Meter?

Yes, a building permit will need to be applied for and obtained to install the Deduct Water Meter. Permits can be applied for through the Village's permit portal Community Core.

The Deduct Water Meter has been installed, what is the next step?

Once the Deduct Water Meter is installed, the owner must contact the Utilities Department at 847-683-2064 to schedule the inspection of the Deduct Water Meter and installation of the outside remote reader.

What are the applicable fees and costs for the program?

Initial Fees:

1. Application Fee: \$100
2. Public Works Inspection Fee: \$100

Permit & Equipment Fees:

1. Plumbing Permit Fee: \$134
2. Water Meter & MXU Cost: \$450
3. Dual Setter Cost: \$1,500
