  - b) Make each and every pick-up from customers' approved trash barrels and containers located not more than twenty (20) feet from truck access-way, and pick-up will not commence prior to 6:00 a.m.
  - c) General liability and motor vehicle insurances with limits of not less than \$500,000 - \$1,000,000 on personnel, equipment, and operations, and contractor shall further provide property damage insurance in a minimum amount of \$100,000 and workmen's compensation and occupational disease insurance in amounts meeting minimum requirements for the State of Illinois.
- 10. This license, if issued, shall not be transferable.
