Waste Management of Illinois, Inc. ("Waste Management") is proud to be the waste services provider for the Village of Hampshire and of the positive relationship that has developed through the years. We see ourselves as Hampshire's partner, working together to improve the Village's cleanliness and quality of life while supporting its environmental and economic goals.

Waste Management presents this letter/amendment for your consideration of the following comprehensive proposal to extend our agreement for (5) five years. We believe our proposal distinguishes our company and its capabilities from our competitors. In addition to the same high level of service Hampshire residents have come to expect from Waste Management, we offer the following value added services. The services described below are subject to the terms and conditions of the 2011 Agreement Between the Village of Hampshire and Waste Management: Collection and Removal of Refuse, Recycling and Yardwaste (the "Agreement"), which will remain in effect.

• Waste Management will hold the current rate for 12 months from the beginning of the contract extension (July 1, 2016). The annual rate adjustment is 3% for years 2-5. The rates for the (5) five-year contract extension are as follows:

Contract Year	Monthly Rate Schedule
July 1, 2016 – June 30, 2017	\$19.75
July 1, 2017 – June 30, 2018	\$20.34
July 1, 2018 – June 30, 2019	\$20.95
July 1, 2019 – June 30, 2020	\$21.58
July 1, 2020 – June 30, 2021	\$22.23

Seniors will continue to receive a 35% discount off the monthly rate.
