A motion was made by Ryan Krajecki to recommend an amendment to the Zoning Code to add a special use in the M-2 zoning district to allow Kennels.

2nd by Bill Rossetti. Motion carried with unanimous "aye" vote by all commissioners.

After an extensive discussion, a motion was made to approve a dog Boarding, Kennel, Training & grooming facility by William Rossetti under the following conditions.

1. The hours shall be: Day Care: Mon Thru Fri. 6:30 AM to 6:30 PM

Sat. 6:30 AM to 2:00PM

Sun. Closed

Training Mon. thru Fri. 7:00 PM to 8:00PM

Sat. 9:00 AM to 2:00PM

Sun. Closed

Boarding Mon. thru Sun. 24 Hrs.

2. An outdoor dog run no greater than 10' X 15' on the south side of the building is permitted.

- 3. There shall be no more than 12 dogs boarded at any time.
- 4. Sales of pet food and other pet related products accessory to the use as a kennel shall be permitted.
- 5. The special use shall be restricted to Unit-9 of building 225 Industrial Dr.
- 6. The Special Use shall expire at the end of the 6th year next following the date of this approval.

A second to the motion was made by Ken Swanson. Motion carried by unanimous "aye" votes from the commissioners.
