**AN ORDINANCE AMENDING THE FISCAL YEAR TO THE CALENDAR
YEAR FOR THE VILLAGE OF HAMPSHIRE, KANE AND
MCHENRY COUNTIES, ILLINOIS**

WHEREAS, the Village of Hampshire, Illinois (the “Village”) is a duly organized and validly existing non-home rule municipality organized and operating under the Illinois Municipal Code (65 ILCS 5/1-1-1, *et seq.*); and

WHEREAS, the President of the Village (the “President”) and the Board of Trustees of the Village (with the President, the “Corporate Authorities”) are committed to ensuring that the Village operates in a proper, economical and efficient manner; and

WHEREAS, the Village is subject to the provisions of the Illinois Municipal Budget Law (50 ILCS 330/1, *et seq.*); and

WHEREAS, Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3) states, “[t]he governing body of each municipality shall fix a fiscal year therefor”; and

WHEREAS, the Village currently operates on a fiscal year that does not coincide with the calendar year, namely, for the period commencing May 1 and ending April 30 of the following year; and

WHEREAS, the Corporate Authorities find that aligning the Village’s fiscal year with the calendar year will promote administrative efficiency, improve financial reporting and transparency, and better coordinate the Village’s budgeting process with state, county and other governmental reporting requirements; and

WHEREAS, based on the foregoing, the Corporate Authorities find that it is advisable, necessary and in the best interests of the Village and its residents to formally establish the Village’s

fiscal year as the calendar year, consistent with the authority granted under the Illinois Municipal Budget Law (50 ILCS 330/1, *et seq.*);

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HAMPSHIRE, KANE AND MCHENRY COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preambles to this Ordinance are full, true and correct and hereby incorporate and make them part of this Ordinance.

SECTION 2. Fiscal Year Established. Pursuant to Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), the fiscal year of the Village is hereby established as the calendar year, beginning on January 1 and ending on December 31 of each year.

SECTION 3. Transition Year. The fiscal year transition necessary to implement this change shall be administered by the Village in a manner consistent with applicable laws, and the Village's Finance Director is authorized to take all actions necessary to ensure compliance during the transition period, including the preparation of any short-year or interim budget required by law. Specifically, there shall be a short-year budget for the period May 1, 2026, through December 31, 2026; a subsequent budget year will commence for the period beginning January 1, 2027, and ending December 31, 2027.

SECTION 4. That the officers, employees, and agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the actions contemplated by this Ordinance.

SECTION 5. That all past, present and future acts and doings of the officials of the Village that are in conformity with the purpose and intent of this Ordinance are hereby, in all respects, ratified, approved, authorized and confirmed.

SECTION 6. That the provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative and unenforceable and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 7. In the event of any conflict between the terms of this Ordinance and the terms of the Village Code, or any other code, ordinance or regulation of the Village, the terms of this Ordinance shall control and prevail in all instances.

SECTION 8. All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 9. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 10. This Ordinance shall be in full force and effect after passage, approval and publication in pamphlet form or as otherwise provided by applicable law.

WHEREAS, the Village of Hampshire, Illinois (the “Village”) is a duly organized and validly existing non-home rule municipality organized and operating under the Illinois Municipal Code (65 ILCS 5/1-1-1, *et seq.*); and

WHEREAS, the President of the Village (the “President”) and the Board of Trustees of the Village (with the President, the “Corporate Authorities”) are committed to protecting the health, safety and welfare of residents and visitors of the Village; and

WHEREAS, pursuant to Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), the governing body of each municipality shall fix a fiscal year therefor; and

WHEREAS, the Village has operated on a fiscal year commencing May 1 and ending April 30 of the following year and is in the process of changing its fiscal year so that it aligns the with the calendar year; and

WHEREAS, to ensure that the Municipal Code of Hampshire of 1985 (the “Village Code”) accurately states deadlines and reflects the Village’s correct fiscal year, the Corporate Authorities have determined that the Village Code should be amended as set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HAMPSHIRE, KANE AND MCHENRY COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preambles to this Ordinance are full, true and correct and hereby incorporate and make them part of this Ordinance.

SECTION 2. That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution or Village Code section to the contrary, by amending the language of Subsection 1-3-4E as set forth below (additions underlined; deletions ~~stricken~~):

1-3-4: DUTIES:

E. ~~The village clerk shall prepare an annual estimate of expenses, as nearly as may be, of the money necessary to defray the expenses of the village during the current fiscal year, to be submitted on or before May 15 of each year, for use in the preparation of the annual appropriation ordinance.~~ On or before May 15 of each year, and before the annual appropriation ordinance is prepared by the corporate authorities (if applicable), the clerk shall submit to the corporate authorities a report of the clerk's estimate, as nearly as may be, of the money necessary to defray the expenses of the village during the current fiscal year. The clerk is authorized to require all officers to submit statements of the conditions and expenses of the respective offices or departments, with any proposed municipal improvements, and the probable expense thereof, all unperformed contracts, and the amount of all unexpended appropriations of the preceding year.

SECTION 3. That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution or Village Code section to the contrary, by amending the language of Subsection 1-4-4G as set forth below (additions underlined; deletions ~~stricken~~):

1-4-4: DUTIES:

G. The Village Treasurer shall, ~~prior to September 1 of each year~~ within six (6) months after the end of each fiscal year, annually prepare and file with the Village Clerk, an account of all monies received and expenditures incurred during the preceding fiscal year. ~~Prior to September 1 of each year,~~ Within six (6) months after the end of each fiscal year, the Village Treasurer shall file with the County Collector a copy of the annual account.

SECTION 4. That the officers, employees, and agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the amendments contemplated by this Ordinance.

SECTION 5. That all past, present and future acts and doings of the officials of the Village that are in conformity with the purpose and intent of this Ordinance are hereby, in all respects, ratified, approved, authorized and confirmed.

SECTION 6. RE: Approval of Contract for Axon Fleet 3 In-Car Camera Systems

Background

The Hampshire Police Department currently utilizes in-car camera technology that is beyond the end of its service life, is no longer available and lacks modern integration with current digital evidence systems. After evaluating available solutions, the department recommends transitioning to the Axon Fleet 3 platform, which integrates with our established Axon evidence ecosystem and provides enhanced video quality, cloud-based storage, state-of-the-art redaction tools, and streamlined evidence management. The system will support automated activation, secure cloud storage, and improved evidence sharing with prosecutors and partner agencies.

Analysis

A quote has been received from **Axon Enterprise, Inc.** for a five-year agreement covering equipment, installation, software licensing, and storage.

The proposed purchase includes:

- Axon Fleet 3 dual-camera systems for **10 squad vehicles**
- Installation and deployment services
- Axon Signal vehicle integration
- LTE connectivity and network hardware
- Unlimited cloud storage and licensing through Axon Evidence
- Extended warranties and refresh coverage under Axon's Technology Assurance Plan (TAP)

Operational Benefits

- Improved transparency and accountability
- Enhanced officer safety through automated activation and integration
- Reliable cloud-based digital evidence storage

- Reduced IT infrastructure burden
- Improved case management and prosecution outcomes

Alignment with modern law enforcement technology standards

Financial Impact

- **Total 5-Year Contract Cost:** \$126,090
- **Contract Term:** 60 months

Grant Funding

The department is under consideration for funding through the **Illinois Law Enforcement Training and Standards Board Camera Grant Program**.

- **Year 1:** 100% grant funded (no Village cost)
- **Years 2-5:** Village responsible for annual payments

The grant funding allows the Village to implement a modern in-car camera system with no upfront capital expense.

**A non-appropriation clause applies to the quote from Axon Enterprises which allows the Village to cancel the contract if the grant funding is not approved.

Recommendation

Staff recommends approval of the five-year agreement with Axon Enterprise, Inc. for the purchase and deployment of the Axon Fleet 3 in-car camera system for ten police vehicles, utilizing grant funding for the first year and Village funding for subsequent years, and authorizing the Village Manager to execute all necessary documents.

WHEREAS, the Village of Hampshire, Illinois (the “Village”) is a duly organized and validly existing non-home rule municipality organized and operating under the Illinois Municipal Code (65 ILCS 5/1-1-1, *et seq.*); and

WHEREAS, the President of the Village (the “President”) and the Board of Trustees of the Village (with the President, the “Corporate Authorities”) are committed to ensuring that the Village operates in a safe, economical and efficient manner; and

WHEREAS, Axon Enterprise, Inc. (“Axon”) provides products and services tailored to assist law enforcement agencies and public safety; and

WHEREAS, Axon has provided the Hampshire Police Department with a quote (the “Quote”), attached hereto and incorporated herein as Exhibit A, which sets forth the terms under which Axon will provide in-vehicle recording equipment and related products and services for police vehicles (the “Products”) to the Hampshire Police Department; and

WHEREAS, Axon and the Village acknowledge that the Products will be paid for, in part, with grant funds and if the grant funds are not received by the Village, the Village has the right to cancel the purchase of the Products; and

WHEREAS, the Products will be used by the Hampshire Police Department to assist officers in carrying out their job duties and keeping the public safe; and

WHEREAS, the Products are unique for police departments and are needed to help ensure that the members of the Hampshire Police Department can effectively and efficiently carry out

their jobs and, therefore, to the extent that any bidding requirements would apply to the purchase of the Products, the Corporate Authorities hereby waive the same and find that the purchase of the Products is in the best interest of the public; and

WHEREAS, to ensure that the Village continues to operate in a safe, economical and efficient manner, the Corporate Authorities have determined that it is advisable, necessary and in the best interests of the Village and its residents to authorize and approve the purchase of the Products in accordance with the terms of the Quote;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HAMPSHIRE, KANE AND MCHENRY COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals as contained in the preambles to this Ordinance are full, true and correct and hereby incorporate and make them part of this Ordinance.

SECTION 2. The purchase of the Products is in the best interests of the public and, therefore, the Corporate Authorities hereby waive any bidding requirements in connection with the same. The Corporate Authorities hereby approve of and authorize the purchase of the Products in accordance with the terms of the Quote, contingent on receiving anticipated grant funds, and authorize the President or his designee to execute and enter into the Quote, with such insertions, omissions and changes as are authorized by the Corporate Authorities. The Village Clerk is hereby authorized and directed to attest to, countersign and affix the Seal of the Village to any documentation as may be necessary to carry out and effectuate the purpose of this Ordinance. The officers, agents and/or employees of the Village shall take all action necessary or reasonably required by the Village to carry out, give effect to and effectuate the purpose of this Ordinance and

shall take all action necessary in conformity therewith. The Village is authorized to allocate, spend and/or receive all necessary funds to fulfill the requirements of this Ordinance.

SECTION 3. That all past, present and future acts and doings of the officials of the Village that are in conformity with the purpose and intent of this Ordinance are hereby, in all respects, ratified, approved, authorized and confirmed.

SECTION 4. That the provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative and unenforceable and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 5. All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

RE: PZC-25-04 - 44W452 US Highway 20 Zoning Entitlement & Annexation Ordinances Repeal

Background: The property owner of 44W452 US Highway 20 requested certain zoning and annexation entitlements, including:

1. Request for an Annexation Agreement between the Village of Hampshire and Hampshire Land, LLC.
2. Request for Annexation of 44W452 U.S. Route 20 (PIN: 01-24-400-042; 01-24-400-041)
3. Request for Rezoning (Map Amendment) upon Annexation from E-1, Estate District to M-3, Industrial District.
4. Request for Special Use per Sec. 6-9-4-C of the Hampshire Zoning Ordinance to permit Outdoor Storage.
5. Request for Variance to Sec. 6-9-4-A-2-c of the Hampshire Zoning Ordinance to permit outdoor storage without a screening wall or fence, whereas a screening wall or fence is required.

The Planning and Zoning Commission held a public hearing on items #3-5 as listed above and had recommended approval of items #3-5 by a vote of 5-0.

The approval recommendation, in addition to items #1-2, was brought to the Village Board on February 5, 2026, for consideration.

Certain requests require a minimum number of votes in order for the item to be approved by the Village Board. A summary of those requests and the minimum votes are provided below:

1. Annexation Agreement Ordinance: Needs to be approved by a minimum of 2/3 of the corporate authorities, which would be 5 yes votes.
2. Annexation Ordinance: Needs to be approved by a simple majority of the Village Board, which would be 4 yes votes.
3. Rezoning (Map Amendment) Ordinance: Needs to be approved by a simple majority of the Village Board, which would be 4 yes votes.
4. Special Use Ordinance: Needs to be approved by a simple majority of the Village Board, which would be 4 yes votes.
5. Variance Ordinance: Needs to be approved by a simple majority of the Village Board, which would be 4 yes votes.

At the Village Board meeting, the following votes occurred for each of the items:

1. Annexation Agreement Ordinance: The Village Board voted 4-1, which means the motion to approve failed since it did not receive the required 5 votes in favor of approval.
2. Annexation Ordinance: The Village Board voted 4-1, which means the motion to approve passed.
3. Rezoning (Map Amendment) Ordinance: The Village Board voted 3-2, which means the motion to approve failed since it did not receive the required 4 votes in favor of approval. So, the property remains zoned E-1.
4. Special Use Ordinance: The Village Board voted 5-0 to approve the special use ordinance. However, because the rezoning vote failed, a special use in M-3 zoning could not occur; therefore, this ordinance is void.
5. Variance Ordinance: The Village Board voted 5-0 to approve the variance ordinance to permit outdoor storage without fencing/screening. However, because the rezoning vote failed, a variance in M-3 zoning could not occur; therefore, this ordinance is void.

Recommendation: The property is now annexed into the Village with E-1 zoning and with a variance to permit outdoor storage without fencing/screening. To address this issue, I recommend an Ordinance to repeal the ordinances mistakenly deemed approved by the Village after the votes were taken. Additionally, I recommend that the staff and I work with the Petitioner to resubmit this through the zoning process as an M-2 request rather than an M-3 request.

Due to the error, I recommend that the Village cover the costs of mailing notice letters to property owners within 250 ft. and of certified mailing to Hampshire Township, Fire District, and Library District, as required by state statute. The Village Attorney has offered to pay these costs and fees and is waiving all billable charges for any work in rectifying this matter. I also recommend that the Village cover the costs of the two newspaper notices required by state statute. A summary of those costs is provided below:

1. Certified Mailing to Taxing Bodies: \$109
2. First-Class Mailing to Property Owners: \$15
3. Planning & Zoning Commission Public Hearing Notice in Newspaper: \$95
4. Village Board Annexation Agreement Public Hearing Notice in Newspaper: \$463
5. Public Hearing Sign: \$315
6. Total: \$997

Due to the requirements of the when the public hearing notice for the Planning & Zoning Commission has to occur, I am planning on taking the zoning requests back to the Planning & Zoning Commission on Monday, March 9, 2026 and then bringing forward the Planning & Zoning Commission's recommendations, annexation agreement, and annexation requests to the Village Board on Thursday, March 19, 2026.

WHEREAS, on or about February 5, 2026, the Village Board passed an annexation Ordinance No. 26-07, a zoning special use Ordinance No. 26-09, and a zoning variance Ordinance No. 26-10, (the “Annexation and Zoning Relief Ordinances”) for property with common street address 44W452 U.S. Route 20 (the “Subject Property”); and

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preambles to this Ordinance are full, true and correct and hereby incorporate and make them part of this Ordinance.

SECTION 2. Repeal of Annexation and Zoning Relief Ordinances. Ordinance Nos. 26-07, 26-09, 26-10 are hereby repealed in their entirety, effective immediately.

SECTION 3. That the officers, employees, and agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the actions contemplated by this Ordinance.

SECTION 4. That all past, present and future acts and doings of the officials of the Village that are in conformity with the purpose and intent of this Ordinance are hereby, in all respects, ratified, approved, authorized and confirmed.

SECTION 5. That the provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative and unenforceable and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. In the event of any conflict between the terms of this Ordinance and the terms of the Village Code, or any other code, ordinance or regulation of the Village, the terms of this Ordinance shall control and prevail in all instances.

SECTION 7. All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 8. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 9. This Ordinance shall be in full force and effect after passage, approval and publication in pamphlet form or as otherwise provided by applicable law.

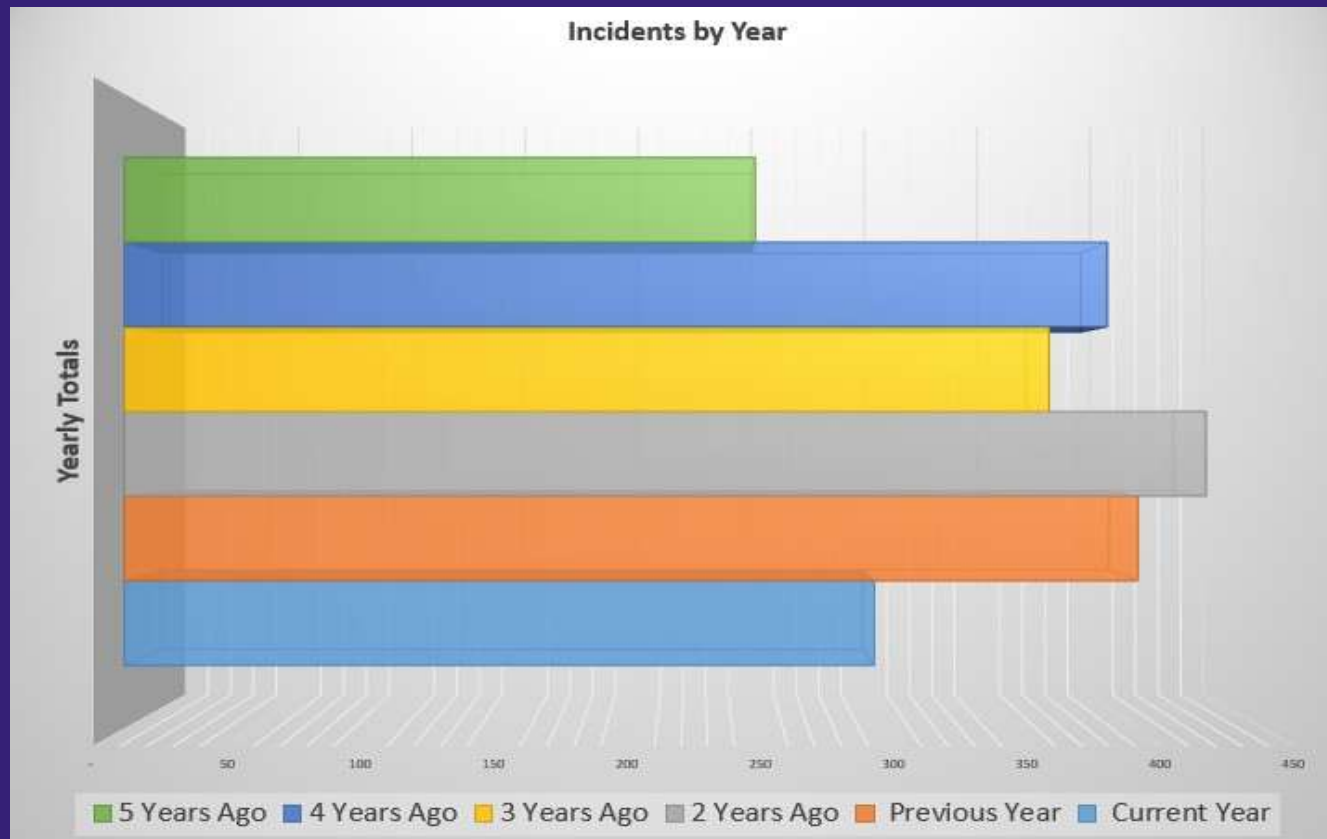

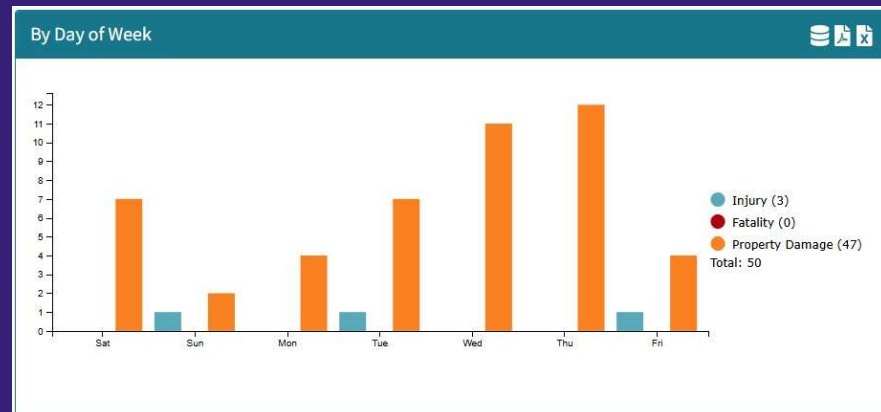
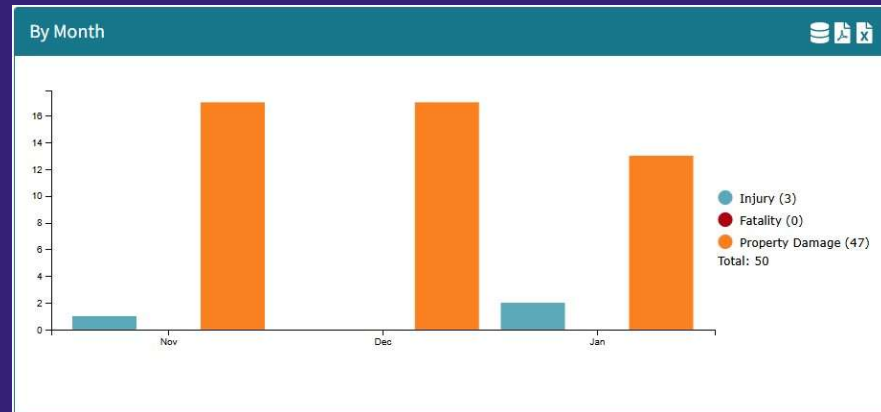
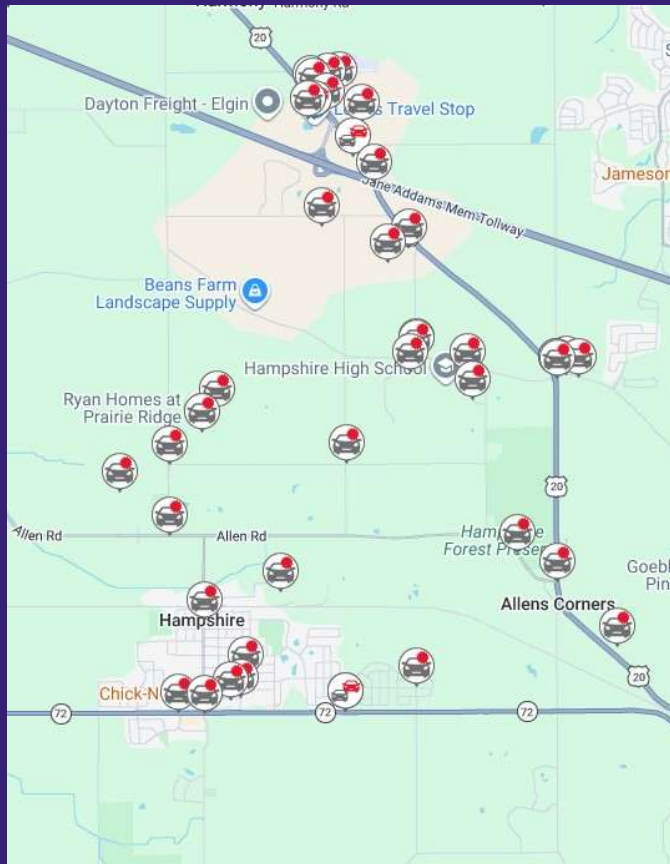

3-MONTH TRAFFIC CRASH DATA

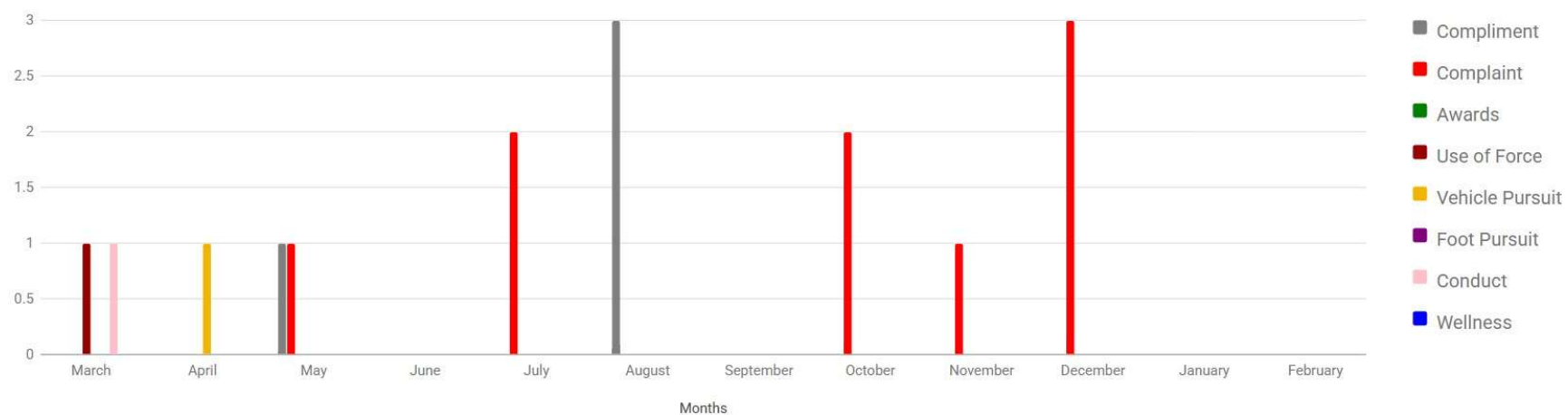
