## Review of the Potential 2<sup>nd</sup> Downtown Streetscape Grant

 Village Administrator Hedges and Assistant to the Village Manager Wray presented the Rebuild Downtowns and Main Street Capital Grants Program (RDMS) and the opportunity it may have as an addition to the current streetscape project (currently scoped for 2022). After further discussion, the Village has decided not to proceed with the application for the grant. Without having clear insight into the scoring and a selfassessed low score, the Village feels that it's chance is low to be awarded.

### <u>Hampshire Township Historical Society Update - Bonnie Engel</u>

 Bonnie Engel presented all the current events and activities that they have been doing to drive awareness of the historical society. They are currently working on developing fundraising activities and donation opportunities as they look to expand to a physical space where they could showcase all the historical elements that they currently have.

### **Beautification Committee Report**

- Commissioner Krajecki walked through the report provided by Commissioner Swalwell:
  - FORMER DOCTOR'S OFFICE on East side of State Street: Windows were ordered and are expected to arrive by the end of October. Facade demolition will commence after the windows have arrived on site.
  - FORMER DOLLAR STORE on East side of State Street: New siding and trim related material has been painted and installed. The build is currently for sale.
  - WASHINGTON STREET PROPERTY next to Basset Rescue: New windows were ordered and are estimated to arrive in 12-16 weeks. After arrival, exterior will be stripped of its siding, windows installed, and new siding applied.
